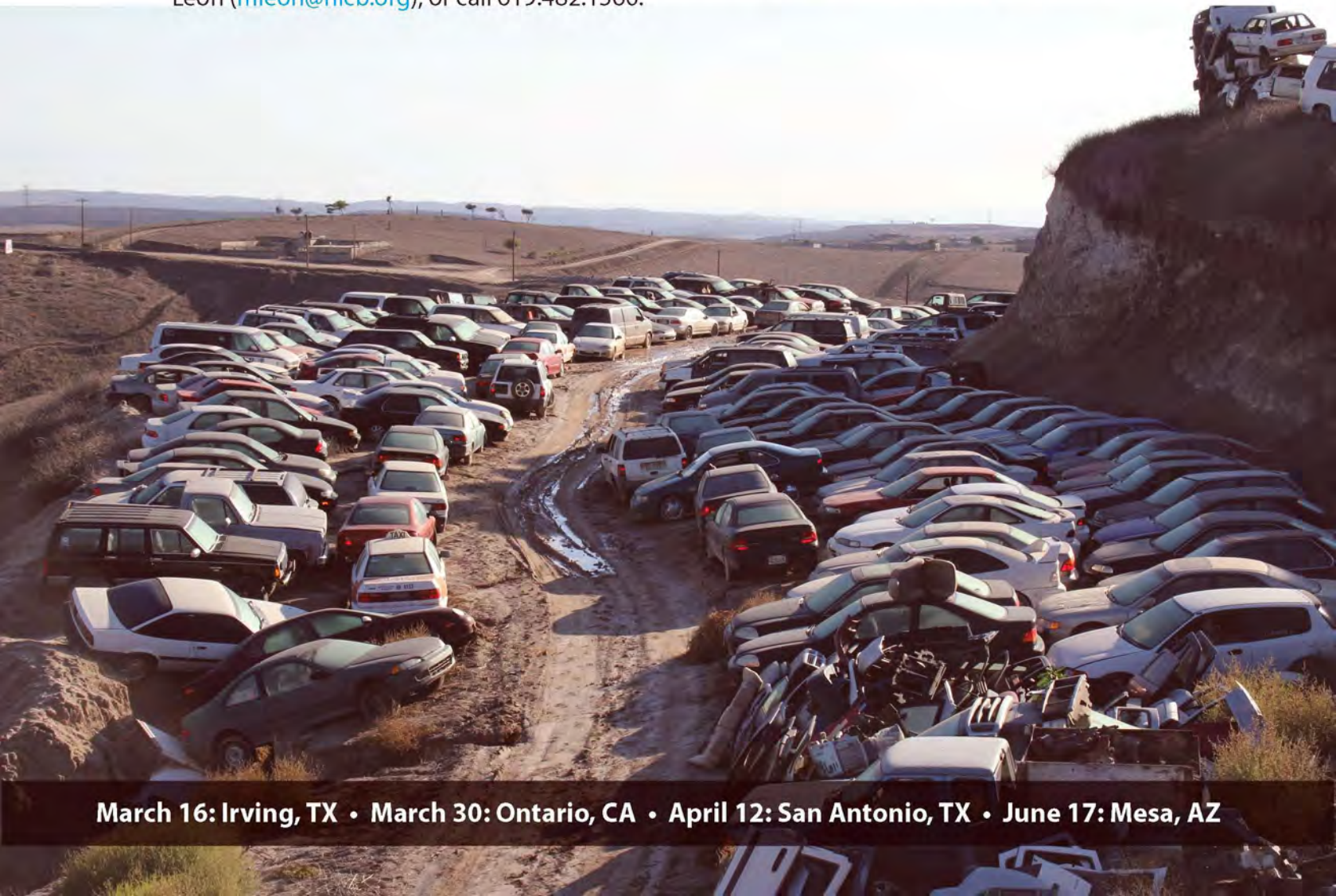
## NICB Foreign Operations Repatriation Seminars
