## **Auto Theft Training for Patrol Officers and Theft Investigators**

**COURSE DESCRIPTION:** Auto Theft Training from the Patrol and Investigative perspectives, what to do, what to ask, and how to proceed once you have a suspect(s). This course will cover locating a stolen vehicle, the traffic stop, identifying a suspect(s) and will take officers step by step on how to proceed with their investigation. Officers will also be given contact information if additional follow-up assistance is needed.

High Tech Crimes Investigator Joe Moody will provide information on how to recognize and handle an Identity Theft suspect(s) and evidence located during a traffic stop.

Auto Theft Task Force Investigator Cory Shell will discuss what Auto Theft Indicators every patrol officer should be using and what to do once you've located a stolen car or auto theft suspect(s) while on patrol.

CHP Investigator John Wilson will share his technique of getting the truth through the use of an "Express Interrogation." Express Interrogation is an easy to remember, three-step "Truth and Fact Finding Process" which can be conducted during a lawful detention, consensual encounter, or traffic stop.
